Term of Office

Directors are elected for a term of two years and may serve three consecutive terms. After three consecutive terms a break in service of one year is required before re-election.

Board Work

The work of the Board is largely done at the Committee or Task Team level with the final approval occurring at Board Meetings.

A "New Director" orientation is provided to better understand NESA and Board Member responsibilities. There is also opportunity to be mentored by a current Board Member.

NESA Board Committees

The NESA Board has six standing committees:

- Executive Committee
- Finance Committee
- Human Resources Committee
- Governance Committee
- Fund Development Committee
- Member Services

Each Board member is expected to serve on at least one standing committee. NESA members at large are also welcomed to serve on committees.

Board Responsibilities

The Board is entrusted with the following responsibilities, acting in good faith, with integrity and in alignment with the NESA Code of Conduct:

- Stewardship of NESA's Assets
- Ensuring organization's compliance with regulating agencies
- Budget approval, including fund development strategies
- Setting the organization's strategic direction
- Governance
- Risk Management

Board Member Attributes

Attributes of a Volunteer Board Member are qualities that enable an individual to contribute effectively to the governance of a nonprofit organization while also respecting its mission, goals, and values. Since volunteer board members are not compensated for their time and effort, they must be deeply committed, strategic, and focused on supporting the organization's success and sustainability.

Key attributes include:

- Strategic Thinking: Understanding the organization's long-term goals and contributing to its direction.
- Collaboration & Respect: Working well with board members, staff, and volunteers, fostering inclusivity and mutual respect.
- Financial Understanding: Basic knowledge of nonprofit finances, budgets, and funding strategies.
- Time Commitment: Willing to attend meetings, participate in committees, and fulfill responsibilities.
- Understanding and appreciating cultural, social, and economic differences in the community and making sure NESA is accessible and relevant to diverse groups. Willingness to continuously learn more about the organization's work, the nonprofit sector, governance best practices, and issues facing the community.
